Part-II-INSTRUCTIONS TO THE CANDIDATES

1. You are called for the OMR Based Examination without verification of the particulars furnished by you in the online application form. Before appearing for the examination, you must ensure that you fulfill the eligibility criteria stipulated in the advertisement for the post in all respect & if anything is found to be incorrect at the time of certificate verification or there after, your candidature for the post shall be rejected without any notice.
2. **The candidates should mention the OMR number and question booklet code correctly in the attendance sheet in the appropriate place.**
3. **The candidates should mention his/her Roll number and Registration number correctly in the OMR answer sheet and accurately darken the circle.**
4. The candidates should use BLUE/BLACK BALL POINT PEN for darkening the ovals in the OMR answer sheet. No rough work should be done in the OMR answer sheet. The correct method of darkening the oval is shown below.



No stray marks should be done elsewhere in OMR answer sheet.

5. Candidates should not tamper with the Barcode of the OMR answer sheet.
6. **The Question Booklet will be bilingual (in Both Odia and English Language).**
7. You are required to bring this Admission Letter along with two recent passport-sized photographs and a valid Government approved photo identity proof in original such as Aadhar Card/PAN Card/Voter ID/DL etc. Please note that your name as appearing on the Admission Letter (provided by you during the process of online registration for the post) should exactly match with the name appearing on the photo identity proof.
Female candidates who have changed first/ last/ surname post marriage must produce Gazette notification/marriage certificate/affidavit to appear for the examination.
8. Candidates are instructed not to wear Shoes. Only Slippers/Sandals with low heels will be allowed.
9. Use of books, notebooks, pouch, pencil box, bags, money purse, calculators, watch, wrist watch, bracelet, metallic items, pagers, mobile phones, electronic gadget and any other device which will help the candidate to manipulate the test shall not be permitted. Candidates are advised not to bring any of the above-mentioned banned items to the venue of the examination. Any candidate found resorting to any unfair means or malpractice or any misconduct while appearing for the examination including giving/receiving help to/from any candidate during the examination will be disqualified.
10. Commission shall not be responsible for safekeeping of any valuable item of the candidate.
11. The candidate shall only bring with him/her this admission letter, 2(two) passport size photographs, Valid ID proof, one black/blue/ball point pen, transparent water bottle to the examination center.
12. Any request for Centre change/date change/Time Change will NOT be entertained.
13. Candidate should reach at the examination venues in time as instructed in the Admission Letter.
14. **Candidates will neither be allowed to enter the Venue after the Gate Closure Time nor permitted to leave before the completion of the Examination.**
15. Canvassing by or on behalf of the candidates or any other outside influence with regard to his/her selection/recruitment shall be considered as DISQUALIFICATION.
16. The possibility of occurrence of some unforeseen/ unavoidable circumstances in the conduct of the examination cannot be ruled out completely which may impact test delivery and/or result from being generated. In that event, every effort will be made to rectify such problems which may include the movement of candidates, or delay in the test, the conduct of re-examination is at the absolute discretion of the Commission. Candidates not willing to move or not willing to participate in the delayed process of test delivery shall be summarily rejected from the process.

Anyone found to be disclosing, publishing, reproducing, transforming, storing or transmission and storage of test contents in any form or any information therein in whole or part thereof or by any means verbal or written, electronic or mechanical or taking away the papers supplied in the examination hall or found to be in unauthorized possession of test content is likely to be prosecuted as per Law and shall lead to rejection of his/her candidature.
18. Mere appearance in the Examination does not confer any right to selection for the post applied.
19. PwD Candidates must submit the Self-attested Xerox copy of their **permanent disability certificates** issued by competent Authority/UDID having disability not less than 40% for availing **Compensatory time of 50 minutes**.
20. **There will be negative marking @0.25 marks for each wrong answer in the Examination.**
21. Candidate will submit the original copy of OMR answer sheet to the invigilator and may take the candidate's copy of OMR answer sheet with them after completion of the examination.

Note

1. This admission letter is purely provisional and subject to rejection. The eligibility of the candidate shall be decided after verification of the original certificates & documents to be submitted by him/her during certificate verification if called for. Submission of false/incorrect information/suppression of any relevant information/non-satisfying the eligibility criteria prescribed for the post shall entail disqualification.
